SUMMERS IN LA CAN BE RUTHLESS. Temperatures soar to the 100s and cause heatwaves strong enough to send people to the hospital. Warm temperatures can be the perfect breeding ground for some insects like bed bugs. When winter rolls around, people assume that the cold temperatures will kill all bugs, and while some insects do fall to the temperatures of LA winter, not all do. Bed bugs are active all year. One reason for this is that most people turn on their heating system to keep their home nice and warm against the outdoor temperatures. As a result, not only are the people comfortable, but the critters in their home hardly even notice the seasonal change.

In order for the cold to effectively kill bed bugs, they must be exposed to -16°C (3.2°F) for 80 hours (3.33 days). Temperatures in Los Angeles simply don't reach that temperature and so it goes without saying that bed bugs can and will survive any winter in Los Angeles for the foreseeable future.

So how can you keep bed bugs away from festering in your mattress? It's always good practice to wash your clothes and suitcase when you return from a vacation. Even if your room was clean, another suitcase's bed bugs could've crawled onto yours.

When you stay at a hotel, make sure to inspect the mattress before you sleep on it. Bed bugs can hide well, but they're not invisible. They're about the size of an apple seed and have a red/brown/copper color.

When you stay at a hotel, the very last thing you expect to find in your mattress are bed bugs. Bed bugs are tiny insects that feed on our blood and leave welts that can not only be incredibly itchy, but painful as well. Medical treatment is often required of such painful welts, and the medical bills associated with bed bug bites can be incredibly costly.

If the hotel's negligence is to blame, then you have the right to file a lawsuit to recover compensation for your damages. Here's the process you should follow after you find bed bugs:

- 1) Take photographic evidence. Every good case needs evidence, and photographic evidence is the best there is. Take pictures of the bed bugs and of your bed bug bites. You may also want to record the room number, and anything else you feel is pertinent to your case.
- 2) Visit the doctor's office. Bed bug bites can be nasty injuries. Apart from being painful, they can result in bacterial or viral infections. It's important that you receive the proper treatment for your injuries it strengthens your case.
- **3) Contact the local Health Department.** You want to contact the local health department because you want them to inspect the room and write a report. A legal report helps your case immensely.
- **4) Notify the hotel manager.** The reason we put notifying the hotel manager fourth is because we've seen so many people lose credibility on their case when they alert hotel staff first. Hotel mangers quickly rush to exterminate the bed bugs. When the health inspector comes to heck out the room, they have nothing to find.



- **3) Seek immediate medical assistance.** Often, pain from a car accident does not manifest until a few days after the accident. To be on the safe side, it is important that you visit the doctor to get checked out.

Q: I was beat up in a rideshare carpooling vehicle, what should I do?

A: All rideshare companies owe their customers a duty of care. A duty of care means that it must adhere to a standard of reasonable care while performing any acts that could foreseeably harm others. In other words, if you are harmed while under care of any rideshare vehicle, you could file a lawsuit to fight for compensation for your damages. This duty of care applies not only if you are involved in a car accident with one of their



vehicles, but also for assault. If the driver or another passenger assaults you while you are in the rideshare vehicle, then that means that the rideshare company has violated their duty of care to you and you can file a lawsuit against them. The amount of compensation you can recover depends on the damages you received, along with other factors.

Q: What should I do if I was hit by a rideshare vehicle as I was crossing the street?

A: The last thing you want to experience while you cross the street is the powerful impact of a car. Unfortunately, getting hit by a car is tairly common and almost always due to human error. If you were hit by a car, you need to call 911. If your injuries are severe request an ambulante. If, however, your injuries do not require emergency medical treatment, take pictures of the accident, of the license plate, driver's license, and insurance information. Then, contact our law firm.
